What is this product?

Type: onemarkets - Difesa Obbligazionario 04/2028 (the "Sub-Fund") is an undertaking for collective investment in transferable securities and is a sub-fund of onemarkets Italy ICAV (the "Fund") which is established as an open-ended umbrella type Irish collective asset-management vehicle with limited liability and segregated liability between sub-funds.

Term: The maturity date of this product is 28 April 2028.

Nova Investment Management Limited is entitled to terminate the contract unilaterally.

Nova Investment Management Limited may terminate the contract unilaterally inter alia in the case of liquidation or merger of the Sub-Fund. Please refer to the prospectus for additional information on early termination circumstances.

Objectives

The investment objective of the Sub-Fund is to seek to preserve the value of the Sub-Fund 's initial offer price by the maturity date of 28 April 2028 and to seek to provide capital appreciation.

The Sub-Fund aims to achieve its investment objective by investing physically and/or synthetically in bonds, which can be fixed rate, floating rate or inflation linked-secutiries, including sub-investment grade bonds. Synthetic exposure is obtained by buying and selling credit default swaps ("CDS") on sovereign bonds. The Sub-Fund does not take short positions.

The Sub-Fund may invest up to 100% of its net assets in Italian government bonds and supranationals. The Sub-Fund may also invest in government bond issued by G10 countries.

The Sub-Fund may also gain exposure to the performance of a basket CDS or credit indices focused on a diversified portfolio of European corporate issuers and to single name CDS referencing European financial and non financial corporations. The Sub-Fund may also sell CDS on government or corporate issuers to gain extra yield and align the portfolio to the maturity date.

The Sub-Fund may also invest in cash and money market instruments.

The Sub-Fund may use financial derivative instruments for efficient portfolio management (including hedging) and/or investment purposes. The Sub-Fund aims at maintaining a leverage effect lower than 300%, calculated on the total of all financial derivative instruments' notional amounts.

The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio, subject to the stated investment objective and policies.

The Sub-Fund does not promote environmental and/or social characteristics in accordance with Article 8 of the SFDR nor does it have as its investment objective sustainable investment in accordance with Article 9 of the SFDR.

You may request the redemption of your units on a weekly basis.

Dividends are not intended to be distributed. Any income derived from the product is reinvested.

Intended retail investor: The Sub-Fund is intended to be marketed to professional investors and retail investors who are able and willing to invest in a fund with a medium investment risk and who are able and willing to forego their invested capital over a 3 year period up to the maturity date.



The risk indicator assumes you keep the product until 28 April 2028.

The favourable scenario occurred for an investment (in reference to benchmark: Representation of the instruments that compose the Sub-Fund) between January 2022 and January 2025.

What happens if Nova Investment Management Limited is unable to pay out?

The assets of the product are held in safekeeping by Citi Depositary Services Ireland Designated Activity Company (the "Depositary"). In the event of the insolvency of Nova Investment Management Limited (the "Management Company"), the product's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the product may suffer a financial loss. This risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the product. The Depositary will also be liable to the product and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

There is no investor compensation or guarantee scheme in the case of default of the Management Company or the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year, you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The recommended holding period has been defined by taking into account the expected composition of the Sub-Fund's portfolio, as well as long-term averages of return and risk for relevant asset classes and markets.

You may request the redemption of your units on a weekly basis. You may receive less than expected if you cash in earlier than the recommended holding period. The recommended holding period is an estimate and must not be taken as a guarantee or an indication of future performance, return or risk levels.

Investors may request redemption at any time. Redemption will be performed by the Administrator normally within 10 bank business days after the relevant dealing deadline.

If you redeem a share from this class within 3 years of the dealing day that the relevant share is first issued, you may be subject to a contingent deferred sales charge of up to a maximum of 1.50% payable on your redemption proceeds calculated as a percentage of the subscription price at which the share was acquired based on a 3 year amortisation of this maximum charge. The imposition of such charge will gradually decrease by reference to the duration for which the share is held in accordance with the 3 year amortisation period commencing on the dealing day that the relevant share is first issued. The impact of such a charge will reduce the redemption proceeds you will receive. Please refer to the section "What are the costs" for additional information.
